## Sassy smoky street fair

In 2022, the first Smoky Lake Street Fair took place in August. This year, the street fair was held on May 18 on White Earth Street. With a slow start at 4:00 p.m. and fewer vendors than in 2022, one could have the impression that it was quieter than expected. However, that was only an impression and not a good one, for as time progressed, more people came out, and the fair became more lively. Vendors varied from art, knick-knacks and jewellery to clothing, decorations, and different types of food. The Senior's Drop-In

Centre sells hotdogs as a fundraiser every Thursday from May through the end of August from 11:00-1:00, and for the occasion, it was selling them at the street fair as well. "We sell on average 100 hot dogs per week", Vern Billy, president of the SDIC, says, "at \$5.00, and that includes a pop. The funds help us pay for the utility bills and keep us going". This Thursday, they far exceeded the 100 hot dogs commonly sold on a Thursday. The H.A. Kostash Grade 11 class also sells hamburgers, and people line up at their stall. "We raise funds for our grad in 2024," Lauryn Boykiw

explains. "We had to get more hamburgers, for we already ran out once." At that time, it was only 6:45 p.m. A group of musicians entertains the public throughout the fair, and as more people come out, it becomes a lively event where vendors do good business. The Victoria Trail Ag Society, which is raffling off a filly, sells many tickets. The filly patiently waits by a trailer, with a buddy. Hopefully, she'll find a good home when the draw takes place. Altogether, this street fair was again a success for Smoky Lake, which may be repeated later this summer.

workshops and demonstrations, an awards ceremony, guest speakers, a live performance by Sofiya Chovojka and a critique to analyze, describe and interpret a selection of works.

Ursula Soria, show coordinator and director, explained that the show accepted artwork from all members of the ACACA that were in the northern zone (north of Highway 14). There are also central and southern shows. Pieces would be judged in their zones, and winners would then move on to larger competitive shows. She explained that this was a very exciting year and one of their biggest shows yet with 100 pieces being entered. Out of the 100 pieces of artwork, 31 were youth entries, 17 of those won awards and would be traveling to the Alberta-wide show later this year in Camrose. The show also featured three prominent artists, a display of sponsored indigenous youth art and a signature artist whose

work has been featured around the world. In the ten categories that were judged, seven of those categories were won by local artists.

The ACACA is the governing body that hosts these shows; it is basically a provincial body of local art and artists. Cindy Clark, president of ACACA, explained that they look for serious art clubs to do the work to host these shows. They are given funding to cover costs, but they are also encouraged to use this opportunity to make a profit for themselves. RAS uses local artists and creates greeting cards sold with prints of their artwork. Clark explained that she comes to all rural shows to touch base with the rural communities. It is a way for her to understand what is needed in these areas and ensure artists have information and support. "How do we go into the future and encourage artists? Do they have help and support?" Clark expounded on the amazing talents that we all have that may go untouched. She spoke

of an elderly woman beginning her journey into the art world in her 80s and the amazing stories of her life that were unveiled with each piece. Members of both RAS and ACACA explained that these were not just art shows and competitions, a place for artists to be pulled out and feed off each other. It is a place of support and encouragement.

Anyone who becomes a member of ACACA is welcome to submit their artwork to future shows. The objective is not to see who is the "best." The purpose is to be a part of a supportive community that welcomes all abilities and levels of talent. The intention is to have someone to lean on and a safe place to express yourself. It is about inner journeys, not fame. Local sculptor Ravi Gill explained his process of creating, commenting, "This is my happiness." The association was summed up perfectly: "When you become a member of ACACA, you become a member of a family."

### COUNCIL MEETING HIGHLIGHTS – May 9, 2023

Below is a brief summary of decisions and discussions at the May 9, 2023, Regular Council meeting:

**Unfinished Business: Proposed Bylaw 07-2023 - Mill Rates**  
Council gave First Reading to Bylaw 07-2023, and will discuss and consider Second and Third Readings at the May 23, 2023, Regular Council Meeting.

**Unfinished Business: Emergency Services Bylaw 10-2022**
