overwhelming. Over 200 county residents, landowners and rate-payers turned up for the meeting. Extra chairs needed to be put out before the meeting could begin to accommodate the number of people in attendance.

The format of the town hall meeting was explained: the council was not there to answer everyone's questions but to receive input to try and solve a tough issue. Attendees were invited to approach a microphone and were given three-minute intervals

to speak. All information proposed to council was documented to be used at a future time in order to assist them with future tweaking and amending of the Emergency Service bylaw.

As residents lined up to take their turns to speak, many issues were brought before council. Most statements were met with agreement or negativity based on each person's personal beliefs. Several topics were repeatedly approached by different individuals. These included thoughts on a cap for the amount that could be charged for emergency

services, self-insuring as a cheaper alternative to combat county costs, adding a small fee to individual taxes to be used for emergency service costs and a variable and yearly adjusted mill rate.

In continuing with other issues, as the emergency service bylaw stands, residents expressed fears that receiving a large bill would "break" them; seniors and many others do not have the disposable income if they were faced with such predicaments. They also questioned the county's ability to rely on the province for additional

funding. Several community members also approached the idea of denying fire and other emergency services on personal property to avoid such large bills. Council was asked why residents do not receive a bill for graders to be on the road, but they would if a fire truck showed up in their yard. There were additional concerns

about how the costs were calculated. Several people also compared the costs of Thorhild County Emergency Services to those of other nearby counties. One thing everyone seemed to have in common was that residents should be held accountable if a service call was required on their property due to personal negligence.

Council listened to residents for over two hours and continually reminded the group that the meeting was not to answer questions but to receive input, understand the concerns, and move forward. On behalf of Council, they issued the following statement: "A big thank you to all the attendees at the town hall meeting, your input is greatly appreciated and will assist Council in addressing concerns with the current bylaw." COUNCIL MEETING HIGHLIGHTS – May 23, 2023

Below is a brief summary of decisions and discussions at the May 23, 2023, Regular Council meeting:

Unfinished Business: Proposed Bylaw 07-2023 - Mill Rates

Council gave Second and Third Readings to Bylaw 07-2023 - Mill Rates. Bylaw 07-2023 authorizes the rates of taxation to be levied against assessable property within Thorhild County for the 2023 taxation year.

Unfinished Business: Cost Analysis Opal Road Ditch Upgrades

At the April 25, 2023, Regular Council meeting, Council directed Administration to bring back a cost analysis on returning 800 meters of the east ditch south of TWP RD 592 and Opal Road to the original design. Administration presented a cost analysis and was directed by Council to proceed with the cost analysis on the Opal Road Drainage Ditch Upgrades from Associated Engineering at an estimated cost of \$12,500, with the funds to be taken from the Operating Reserve.

Unfinished Business: Newbrook Recreational and Agricultural Society Lease

Council previously requested clarification on the lease agreement between Thorhild County and the Newbrook Recreational and Agricultural Society. The Friends of Newbrook Library supplied a landscaping plan for the area surrounding the Newbrook Library, along with their intent to fund and maintain the area. Council moved to approve the proposed landscaping plan.

Public Hearing: Proposed Bylaw 08-2023 - Land Use Bylaw Amendment

Upon the conclusion of a public hearing for proposed Bylaw 08-2023, Council gave Second and Third Readings to Bylaw 08-2023 to amend Land Use Bylaw 1194-2015 to include "Recreational Vehicle Campground" as a Discretionary Use under the Agricultural Land Use District on Pt. NW 10-63-19-W4M consisting of 7.83 acres.

Delegation: Bryan Hetlinger - Request to Waive \$500 Lagoon Fee

Mr. Bryan Hetlinger attended the Council meeting to request that the County waive a \$500 lagoon user fee. Council moved to decline the request to waive the fee. They also directed Administration to bring back Bylaw 01-2023 - Water and Wastewater Rates to include a deposit fee of \$50 a year for Thorhild County residents.

Delegation: Together Enriching All Minds - Kristina Krause

Ms. Kristina Krause joined the Council meeting on behalf of Together Enriching All Minds Society regarding their request for the County to gift the bus listed for sale to the students of the Thorhild Central School in exchange for promotional advertising. Council passed a motion directing Administration to communicate with Together Enriching All Minds Society and Thorhild County seniors groups on the joint usage of the advertised bus, and that the option of the bus being transferred to Together Enriching All Minds Society in conjunction with the seniors groups, and report back to Council.

Establishment of the 2023 Public Auction Date

Administration advised that the Municipal Government Act (MGA), Section 418(1) requires that municipalities must offer for sale at a public auction any parcel of land shown on the County's tax arrears list if the tax arrears are not paid. As there are properties listed on the County's tax arrears list with unpaid taxes, Administration requested that Council authorize a public auction on Tuesday, August 8, 2023, commencing at 10:00 am to offer the properties listed on the tax arrears list for sale. Council authorized the public auction.

Correspondence: Kelly Feledichuk - Thorhild Memorial Charity Slo-Pitch Tournament Request

Ms. Kelly Feledichuk wrote a letter to Council on behalf of the Thorhild Memorial Charity Slo-Pitch Tournament requesting a permit that allows tournament participants free camping at the Thorhild community campgrounds and to waive the fee for the use of all the baseball diamonds from June 9 - 11. Council directed Administration to issue a permit to the Thorhild Memorial Charity Slo-Pitch Tournament that allows participants free camping at the Thorhild community campgrounds and to waive the fee for the use of all baseball diamonds from June 9 to 11, 2023.

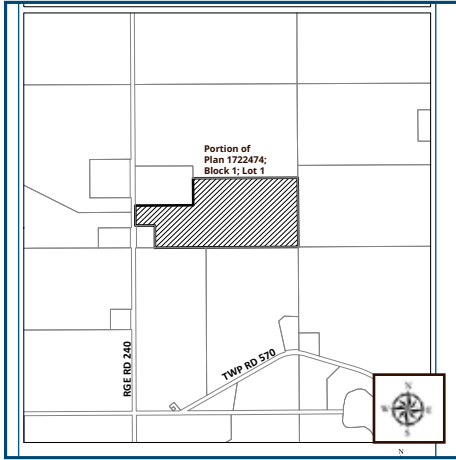

What is Bylaw 914?

Bylaw 914 proposes to establish rules that encourage and ensure responsible dog ownership and dog related matters within the Town. This includes the licensing, regulation and control of dogs that ensure dog owners protect their pets and are considerate to neighbours and community safety.

What does this mean?

Bylaw 914 would repeal Dog Control Bylaw 762. The new bylaw will remove administrative red tape, and promote responsible pet ownership.

How can I get more information

Any member of the public may review the proposed bylaw and ask questions. A copy of the proposed bylaw is available at redwater.ca or you can visit the Town Office or Community Services during office hours where staff can explain what is proposed, how it might impact you, and how the Public Hearing process works.

Fire and OHV ban lifted, fire restriction in effect in Sturgeon County

Effective (May 31) at 4 p.m., Sturgeon County and the towns of Bon Accord, Legal and Redwater are under a fire restriction.

The fire and OHV ban issued earlier this month has been lifted; however, open fires – including burn barrels and incinerators – and fireworks are not allowed.

All outdoor fires presently burning must be extinguished. No new burn permits or fireworks permits will be issued, and all permits previously issued remain suspended.

You can use the following:

- recreational firepits for warming or cooking
- OHVs and ATVs
- charcoal/pellet barbecues
- propane/natural gas barbecues
- charcoal/pellet appliances, like smokers
- propane/natural gas appliances, like patio heaters and fire tables
- electric appliances, like smokers
- outdoor fireplaces/chimineas

Sturgeon County urges the public to use extreme caution when working or driving in grassy areas, and to keep vehicles clean and free of debris as smoldering debris can start fires.

This restriction does not apply to the use of ATVs or OHVs.

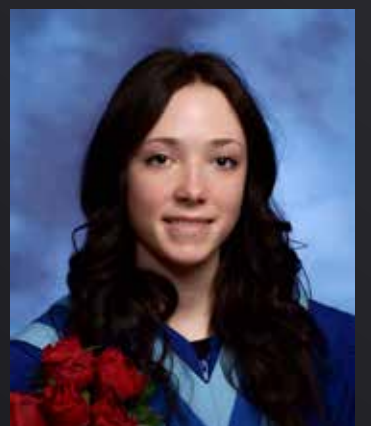

Proposed Resource Extraction Changes

PUBLIC HEARING –BYLAW 1607/22

Amendments to Land Use Bylaw 1385/17

In accordance with section 606 of the Municipal Government Act, Sturgeon County Council is requesting public input on new changes to proposed Bylaw 1607/22, which relates to resource extraction.

Council gave second reading to Bylaw 1607/22 on May 23, 2023. In addition to the regulations presented at the public hearing on March 15, 2023, the bylaw includes the following updates:

- Sand, gravel and clay operations and secondary processing operations would need to be at least 400 metres (quarter mile) from homes whether located in a multi lot subdivision or not.
- Silica sand and secondary processing operations would need to be at least 800 metres (half mile) from homes whether located in a multi lot subdivision or not. Silica sand is made up of at least 95 per cent silicon dioxide and less than 0.6 per cent iron oxide.

The existing and previously proposed bylaw presented on March 15, 2023, had setback distances of 400 metres between operations and single homes and 800 metres between operations and multi-lot subdivisions. The setback distances were the same for all operations, regardless of the material being mined.

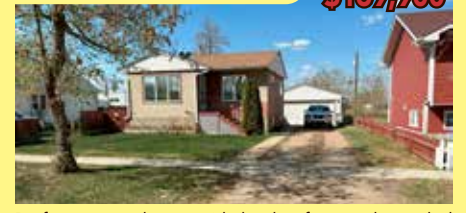

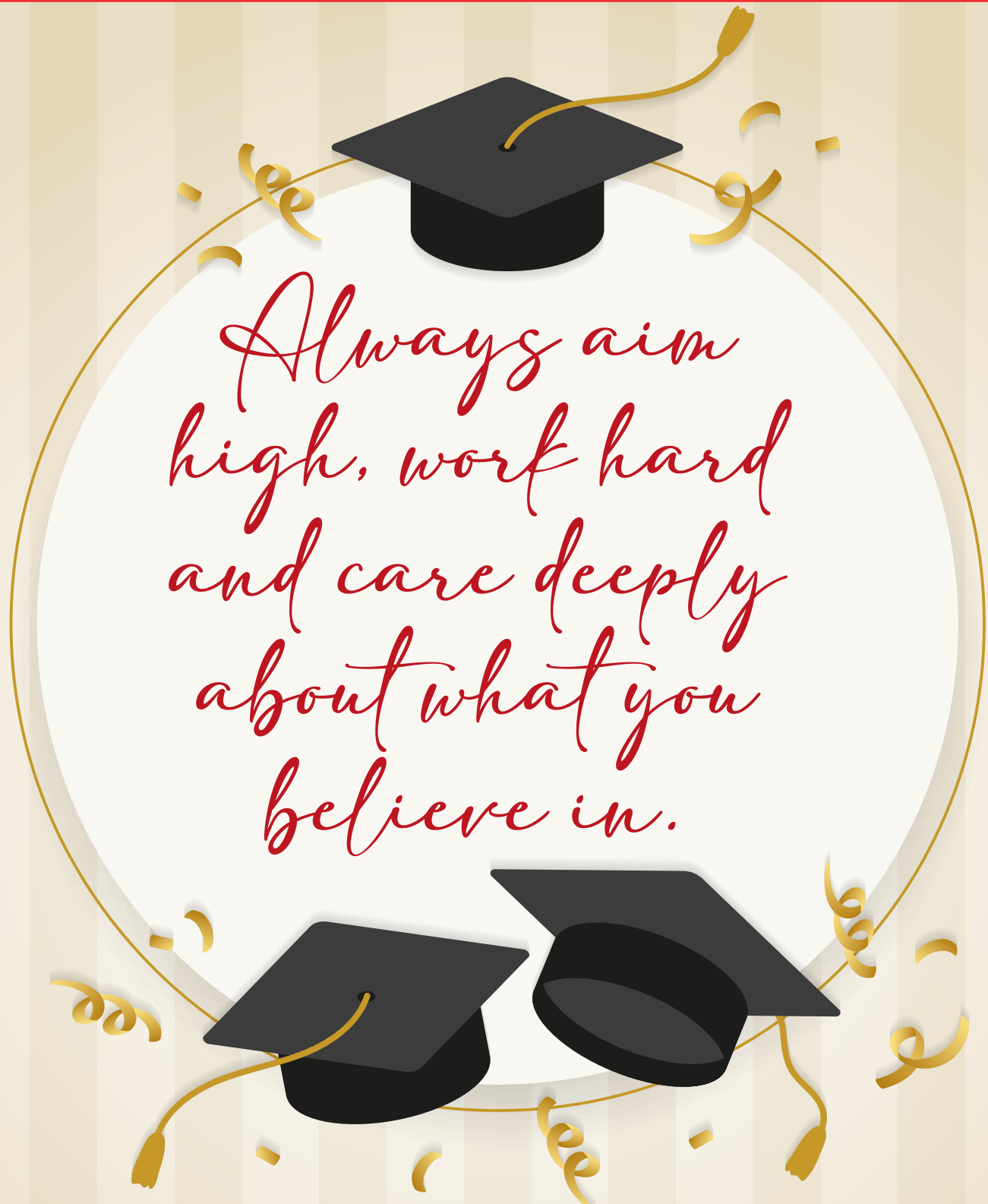
