Newer families moving to the area, in addition to a population of aging individuals, have the opportunity to go somewhere that is close, accessible, and affordable. Monthly crafts are set up for children, and the coffee pot is always on for those just wanting a place to stop and visit. Patrons are also invited to drop in and sit down at the crossword table, showing off their skills and wisdom with tricky puzzles. Libraries have always been a place to visit to expand your knowledge, providing access to the written word and a variety of media resources where individuals may not be exposed to those opportunities without them. In rural communities, they have evolved into something more. Libraries are becoming the heart of a community, and Radway Public Library demonstrates this in everything it does. From the welcoming, smiling nature of Sandra Moschansky to the exuberant party atmosphere apparent in the guests who stopped by, it may not only be the heart of the community but also the very pulse that keeps this community alive.

Alberta population booms

Alberta led all provinces in population growth this year. The influx of new residents is fueling consumer spending and housing demand, while adding to the province's labour supply.

As of July 1,2023, an estimated 4.7 million people called Alberta home according to annual population estimates released by Statistics Canada this morning. That is 4.1% higher than the same time last year—or an additional 184,400 people.

In the demography world, the midpoint of the year is the reference point for the calendar year. With the 2023 data in hand, we can compare 2023 to previous years going all the way back to 1926.*

- In percentage terms, the last time population growth was this high Stars on 45 and John Lennon were topping the charts. For music buffs, that's 1981, when the population grew 4.6%.
- In people terms, however, no other year comes close. This year's increase in the total population outmatches the previous record in

ulation in Alberta, thanks to the relatively high proportion of young families living here. In 2023, natural increase contributed 15,592 new people to the province, or 8% of the total increase.

Net Interprovincial migration in most years adds to Alberta's population, especially during periods of rapid growth. In 2016-2021, there were net outflows from the province following the oil price crash and recession. But since late 2021, that trend has rapidly reversed. Stronger job growth and relatively affordable housing has contributed to the upswing. In 2023, net interprovincial migration was responsible for adding 56,245 people to the province, or 31% of the total increase. Nearly three-quarters (73.5%) of the gain came from net inflows from Ontario and BC.

 Net International **migration** is the biggest driver. Increased federal immigration targets, along with a jump in non-permanent residents**. has pushed the contribution of international immigration to record levels. In 2023, international migration added 112,562 new people to the province, or 61% of the total increase. Digging into the latest quarter, Alberta's population grew by 1.1%, or 50,061 people. Net interprovincial flows remained strong at 13.926 and the main sources continued to be BC and Ontario. Natural increases accounted for 4,764 of the increase, with international migration the remainder.

This year, Alberta's population outpaced the national average by 1.1 percentage points. That's not to take away from the sizable increase in the national population (+3.0%), which is the fastest since 1957, and stronger than any of the G7 countries.

Statistics Canada has, for the first time, incorporated 2021 census population counts adjusted for net undercoverage. As part of their adjustments, the agency revised down its estimate of previous quarters. This results in a lower estimate of the Alberta population as of April 1, 2023 (now 4,645,229 vs. 4,703,772 previously). It also lowers the previously reported annual growth between April 1, 2022 and April 1, 2023 from 4.5% (200,914 people) to 3.7% (164,273).

The influx of people in Alberta has contributed to the recent surge in housing demand and resilient consumer spending. It's also added to the labour force, which is growing at its fastest annual pace since 2007, leaving aside the COVID recovery.


What accounts for the spike? Population growth has come from all angles this year, but it is mostly due to a spike in international migration. An influx of other Canadians coming to Alberta also added significantly to the gains, propelling Alberta's growth ahead of other provinces.







Volunteer driving program helps Smoky Lake seniors

Seniors who need to go out of town and do not have transportation or do not like to drive in the city now have a reasonable alternative in Smoky Lake: Drive Happiness. Drive Happiness is a government-subsidized program offering affordable transportation and door-todoor service using volunteer drivers. The program is remarkably cheaper than a taxi and more personable because the rider goes with a volunteer. Recently, Betty Lou Slipchuk from Smoky Lake needed to go to Edmonton to renew her passport.

and the country, but I don't like driving in Edmonton," she said. "I am on the FCSS Board; Smoky Lake FCSS got the grant for Drive Happiness. We talked about it, but the program just needed to get started, so Dennis Hoberg and I spoke about making this trip and seeing how it all works. Dennis had to take a few steps to be able to do this, like filling out some paperwork. Normally, a trip like this costs \$200 with a regular taxi; now, it costs \$80. That is a huge difference, especially for a senior. To get a drive, a person must go to the Town office in Smoky

"I drive in the area and the country, but I don't like driving in Edmonton," she said. "I am on the FCSS Board; Smoky Lake FCSS got the grant Lake and buy tickets at a minimum of \$100 in increments of \$10. Whenever you take a trip, no matter where you go, it gets charged to your tickets. When

we made the trip, Dennis had to call about our departure time, and I had to call to confirm I was in his vehicle. Normally, you would call when

you got home, but the trip took longer than anticipated (because I had to wait four hours at Service Canada), so we got back late and called the next day." Betty Lou thinks this is a great asset to the services offered in Smoky Lake. "When I called, the lady at the Drive Happiness office said she had never had such a long trip. Usually, trips are about 20 kilometres one way". Three drivers in Smoky Lake and the surrounding area are offering a ride through this program, and FCSS is looking for more volunteer drivers. The program is located out of Edmonton - Smoky Lake was approved

for a grant - and focuses on seniors only. "Our vision is a future where all seniors, regardless of barriers like income, health or mobility challenges, can access assisted transportation services to remain active and engaged in their communities," it says in their brochure. The program is volunteer-driven, and riders must book at least three business days ahead of time. Drivers need to sign up and provide information to the Drive Happiness program before being approved, but it is a simple process. Anyone willing to drive a senior can sign up to become a driver.

Friends of Medicare Harvest Supper

When Mandy Melnyk, a member of The Gathering Place Co-op, reached out to Chris Gallaway, the executive director of Friends of Medicare, for an opportunity to partner together and discuss concerns about public health care between urban and rural areas, he immediately accept-On September ed. The Gathering 16, Place Co-op became part of a tour Southern through Alberta promoting Friends of Medicare and raising awareness of their cause. The Ukrainian Dinner Community and Conversation received an overwhelming response, with two separate seating times, and all tickets were sold out. The attending guests ranged in age, with families gathering with their children, through to seniors voicing their unease. The group was diverse and represented a significant portion of the population.

Gallaway provided the following statement: "We have been hearing growing concerns from folks in drive from Edmonton the region about their ability to access family doctors, primary care, and hospital care when they need

it. This has intensified with the recent temporary closures of the Emergency Rooms in Smoky Lake and Lac La Biche, as well as various closures in area health centres such as Boyle, Westlock, and St. Paul's. Rural communities are feeling the staffing crisis in our health care system most acutely. We continue to call on our provincial government to take this issue seriously and work to ensure every community in Alberta has the health services they need."

Friends of Medicare is a non-profit advocacy group established in 1979. They are dedicated to promoting, protecting, improving, and expanding the public health care system, working to keep these issues in the public Presentations eye. and media relations are utilized to advocate for issues in the public health care system. Chris Gallaway began the opening presentation for the harvest supper by recounting his childhood on a farm in Saskatchewan. He mentioned that the to this small rural community was a poignant reminder of the deficiencies in the health care system. As

Gallaway passed combines and farm equipment hard at work in the fields during the busy harvest season, he couldn't help but think of the lack of access to emergency services in these areas. His initial speech initiated а community discussion where individuals could converse about their struggles either working in the field or their experiences attempting to be treated in an under-resourced, understaffed health care facility.

Professionals opened up about feeling overwhelmed in urban centers due to the influx of patients coming from rural areas because they have no access to emergency services. Concerns about closures and proper seniors' care punctuated the conversations, as well as concerns about misconceptions regarding what is really happening in the health care system. Many attendees also felt that the strain may be the result of a push for a more privatized health care system. Voices came together expressing that the lack of health care staff is patients in areas that due to infrastructure and poor conditions: the staff is there, they are just leaving the system. Continuing

the conversation were concerns about a lack of government investment, proper infrastructure and equipment, and discouraged health care professionals finding they cannot do what they need to with what they have.

Pharmacists, nurses, other health care professionals, and supporters of the cause used this event as a valuable tool for community building and bridging a connection between urban and rural areas. The event raised awareness that both demographics are facing the same issues but feeling the strain in different ways. While attempting to sustain these rural communities, the cost and lack of health care resources are straining families with a delay, or even a lack, of access to proper health care. As these patients move to larger areas for care, health care providers explained their increased caseloads, with many being asked to step into roles to fill the gaps where care is lacking, and occasionally providing services to

band-aid solution. Others followed with comments that they were alarmed because many individuals are unaware of how challenging the health care system really is and how important it is to support this cause and have conversations about the challenges the health care system is facing. While the evening was punctuated with laughter and loud, friendly conversations, the underlying issues weighed heavily on the minds of the guests. Mandy Melnyk offered a perfect summary for the

evening: "We have many advocacy organizations in Alberta that work in the interest of the people, and Friends of Medicare is very important. Our health care system was built on the core cooperative values, so it is incumbent on all Albertans to support the work that is done on behalf of the people! I am simply a member of the Gathering Place Co-Op but believe strongly in supporting all people in Alberta and building bridges between urban and rural people and organizations.'

The addition of the two EV chargers provides a dual outcome for the Town. Not only providing residents and travellers improved EV charging infrastructure, but the chargers also position the Town to take

advantage of current green initiative fleet funding grants and future options to purchase green fleet. For instance, an electric Zamboni would see emissions and fume/ vapour reduction in the arena coupled with fuel savings. The addition provides

options for the Town to reduce operating costs and put these towards prioritized infrastructure.

The electric vehicle charging project began its planning phase in September 2022, with the installation of two level 2 commercial network capable EV chargers taking place in June 2023. After some initial delays the project saw completion in early September 2023. The total cost of the project was \$17,790.00 for the two EV connectors. South Grow Reginal Initiative funded

46% of total costs of each level 2 connector to a maximum \$5,000.00 per of connector/charger. We would like to express our appreciation to South Grow Regional Initiative (SGRI) and the Municipal Climate **Change Action Centre**

(MCCAC) for the opportunity to complete this project and residents provide and travellers in and around the area with options for a safe and comfortable place to charge and providing options for choice and diversity in vehicle selection and type.



Mayor Alanna Hnatiw proclaimed September 18 to 22 as Alberta Development Officers Weekin Sturgeon County.

<u>Public hearing –</u> Bylaw 1624/23

Council held a public hearing for Bylaw 1624/23 for the public to provide input before Council considers the proposed bylaw further. The applicant would like to operate an event venue on their land at 26127 Highway 633 (NW-11-54-26-4); this land is currently zoned as AG – Agriculture District. To operate an event venue in Sturgeon County. land must be zoned AG2 - Agriculture 2 District. Council will consider the presentations and submissions and will make a decision at a future Council meeting. Land Use Bylaw matters

a landowner's proposal to operate a disc golf facility on their property. Bylaw 1628/23 proposed to redistrict a portion of land near Range Road 240 and Township Road 570 (NW-06-57-23-W4M; Lot 1, Block 1, Plan 1722474) from AG – Agriculture District to Direct Control District 23.

Council gave first reading of Bylaw 1633/23, which proposes to redistrict 56210 Range Road 253 (Lot 1, Block 1, Plan 1220583) from AG Agriculture District to AG2 – Agriculture 2 District with the intent of operating an event venue. This parcel is located roughly two kilometres north of the Town of Morinville near Highway 2, with direct access via Range Road 253. To operate an event venue in Sturgeon County, land

must be zoned as AG2

- Agriculture 2 District.

If the redistricting is

successful, the applicant could then apply to develop an event venue. A public hearing will be scheduled and will allow adjacent landowners to provide their feedback before Council considers the proposed bylaw further. 




