



Family Resource Network program extended for two more years

The Family Resource Network (FRN) launched in April 2020 replacing the previous Parent Link Centres, creating a newly developed system and structure, and expanding its services and resources for families with children of all ages. Parent Link centres previously focused on free programs for families with young children, ages 0-12 and then

adjusted to ages 0-6. The revision of the new model as Family Resource Network brought uncertainty and unknowns but was also an opportunity to offer expanded services and revise current programming and services.

The Rural Connections Family Resource Network works in partnership with a central hub along with other agencies to

Standing tall: Best six months for housing starts in a decade

Alberta housing starts* made a big splash to finish the year with 44,300 units (seasonally-adjusted at an annual rate) in December 2023, lifted by gains in Edmonton.

After a sluggish first half, starts swiftly gained (and retained) momentum in the second half. They averaged 42,700 units between July and December—the highest average for a six-month period since 2014.

Alberta's performance is even more impressive when compared with the national economy, where starts over the second half of 2023 were down by 7.2% compared to the same period in 2022.

For the full year,

starts in Alberta came in at 36,000 units, shy of the 36,500 units in 2022 due to weakness in the first half. This was a bit more optimistic than what we expected in our December outlook.

The annual 1.4% decline was entirely driven by a pullback in single-detached homes (-13%) which outweighed increases in multi-family units (+6.5%).

Seven out of ten provinces posted declines in starts in 2023, led by Quebec and Newfoundland & Labrador. With monthly starts down in seven out of twelve months last year, Canadian starts retreated by 8.2% in 2023—the starkest retreat witnessed in a

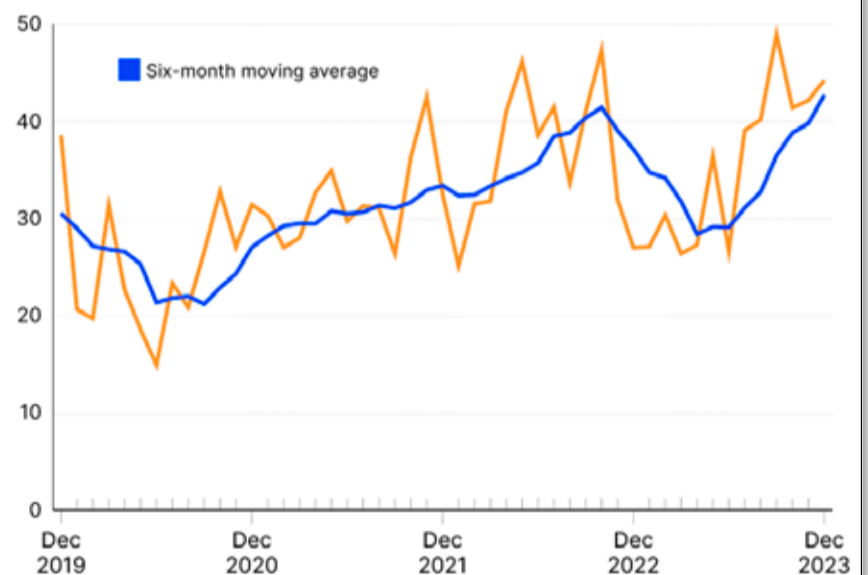
decade, as higher interest rates weighed.

Looking ahead, we expect healthy migration levels to continue to boost housing demand in Alberta in 2024 despite the headwinds of higher borrowing costs and staffing challenges in the construction sector.

*A housing start is defined as the beginning of construction work on the building where the dwelling unit will be located. This can be described in two ways: 1) the stage when the concrete has been poured for the whole of the footing around the structure; or 2) an equivalent stage where a basement will not be part of the structure.

provide safety and an array of assets to all families in the community. The Rural Connections Family Resource Network works underneath this hub, extending down to Healthy Families Healthy Futures and WJS Canada. Healthy Families Healthy Futures supports, but is not limited to, home visitations and early childhood development with children ages 0-6 while WJS Canada provides, but is not limited to, home visitations and parenting strategies to families with children aged 7-18. Following this unique hub and spoke model for the Rural Connections Family Resource Network, caregiver capacity falls upon the individual family resource centers including Thorhild, Smoky Lake, Barrhead and Westlock. This is the

basic model for the Rural Connections Family Resource Network and will not be the same as other areas, siting that other FRN may not offer the same services and may be structured in similar or diverse ways.

The support provided by Family Resource Networks focuses on providing prevention and early intervention services across communities and connects families to each other and an array of supports and services, including free home visitations, assessments, parenting guidance and parent group supports. After the initial roll out of the program, FRN was established as a three-year model which would conclude with a reassessment and evaluation before moving forward. Originally announced that there would be a one-year extension,

Family Resource Network directors were eager to share an announcement received in December of 2023 that the past three years have been demonstrated positive outcomes of the current model and is achieving growth and new connections and partnerships across communities. In addition to the success reflected upon with this statement also came the declaration that the Family Resource Network program will be extended for an additional two years and looks forward to the continuity of the programs.

This announcement eased an uncertainty as the 2024 deadline was approaching, ensuring the stability of funding for the upcoming years. The impact of this decision ensures the ability of continued work development and maintaining future programs.

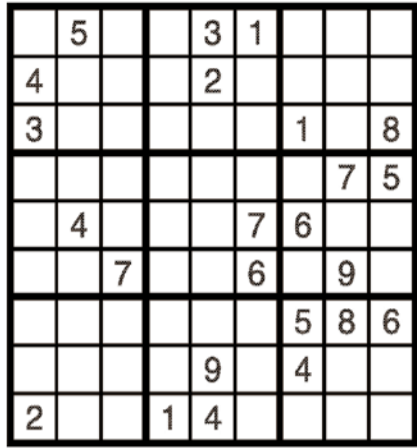

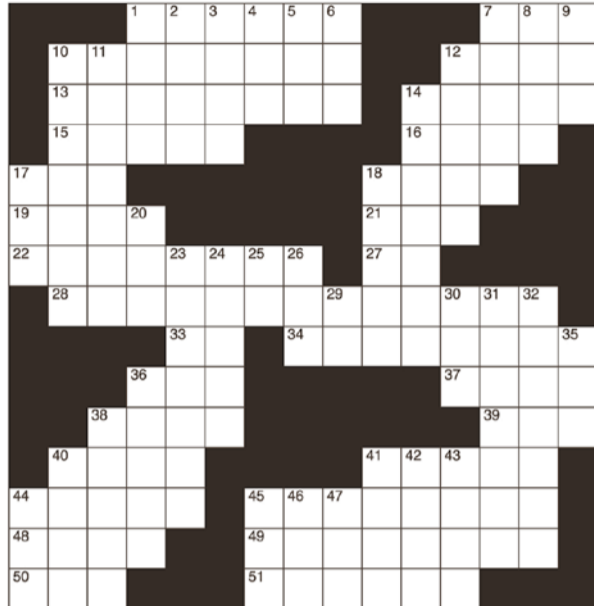

COUNCIL MEETING HIGHLIGHTS January 9, 2024

Below is a brief summary of decisions and discussions at the January 9, 2024, Regular Council meeting:

DRIVEWAY SNOWPLOWING/SNOW FLAGS

Thorhild County operates a driveway snow removal program for residents (excluding hamlets) who register and pay for flags.

Driveway snow clearing does not involve snow clearing of the yard. Driveway clearing consists of one pass in and out on the driveway. If custom cleaning is required, the resident should make arrangements with a private contractor.

Persons wishing to register for driveway cleaning must sign an easement, pick up and pay for a flag, and place it at the end of the driveway after the storm has passed, in a location where it is visible to the grader operator.

Please call the Thorhild County Administration Office at 780-398-3741 to purchase a flag. Flags can be picked up from the Administration Building or Public Works Office. Registered landowners are required to sign a yearly easement.

- Driveways will be addressed after all County roads are cleared
- Driveway Plowing consists of one pass in and back out
- Each flag is good for one plow only

Residents must register for and purchase flags before the work is done. Fees are as follows:

- \$35.00/Flag
- \$20.00/Flag for seniors 65+ who are physically living on the property and can provide age verification.

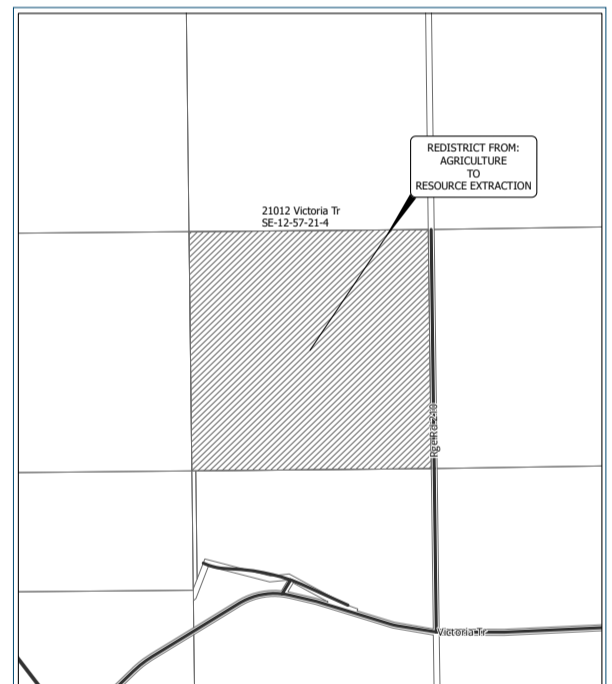

Winter Walking Tips

With the beauty and fun of winter comes the potential for hazardous conditions, particularly when walking outdoors. Slippery sidewalks and icy pathways can pose a significant risk for falls and injuries. Often, thin layers of ice are difficult to see when melting snow freezes overnight. No matter how well the snow is removed from parking lots or sidewalks, there will still be slippery places.

Tripping and falling can cause damage such as bruises and sprains, or even more serious injuries such as broken bones or concussions. So, it is important to keep in mind winter walking safety tips during the colder months.

How can I avoid slipping and falling on snow or ice?

• **Proper Footwear** – What you wear on your feet can help lower your risk of falling. Boots or

shoes that fit well and have a good grip are the best choice. Special items like shoe grips or ice cleats can give you extra traction when you're walking on snowy or icy surfaces. You can buy these items from places like department or sporting goods stores. Always take off these grips or cleats when walking inside because they can make you slip on indoor flooring.

• **Be careful when walking!** – Find a path around snow or ice when you can. Learn how to Walk Like a Penguin. Walk slowly, take small steps, and point your toes out slightly to be more stable on icy paths. Keep your head up and don't lean forward. Keep your hands out of your pockets to help keep your balance. If you use a cane, you can buy an ice pick for

the cane.

- **Plan ahead** – Make sure you have enough time to get where you're going. Rushing or not paying attention to your steps can often lead to falls or the potential to slip on icy surfaces. Assume that all wet, dark areas on the pavement may be slippery or



icy. If you can, walk around them.

- **Walk on cleared walkways** – Choose well-maintained routes with minimal ice and snow accumulation whenever possible. Sidewalks that are regularly cleared of snow and ice are safer for walking. Avoid shortcuts that haven't been cleared.
- **Check the weather!** – Download a

local weather app on your phone (such as Government of Canada Weather Alerts) so you know what the weather is like before you go outside. Sudden changes in the temperature can cause ice to melt and freeze, making the ground more unpredictable.

- **Pay attention** – Stay vigilant and be aware of your surroundings, especially when walking in unfamiliar or potentially hazardous areas. Watch for patches of ice, snow-covered obstacles, and uneven surfaces. Don't text or talk on your phone and walk at the same time, as this can divert your attention from potential dangers.
- **Use handrails on stairs and ramps** – If you're walking on a slope where there are no handrails, be extra careful. Consider using walking aids such as trekking poles or

an ice grip attachment for your cane to provide additional stability. These aids can enhance your balance and help prevent falls, especially on icy or uneven terrain.

- **Spread sand or grit on your steps and walkways** – You could also try carrying a small container of sand or grit to sprinkle on icy or sloped surfaces that you can't walk around.

• **Travel light** – Try not to carry heavy things that can make you lose your balance, or large things that could block your view. If possible, use a backpack to keep your hands free.

Taking a walk is a great way to enjoy the beauty of the season and it is one of the best ways to keep fit. But just one bad fall can have long-term consequences which is why it is important to be prepared, plan ahead, and Walk Like a Penguin!

heart, fertility and other health problems.

and devotion to the safety and growth of its community.

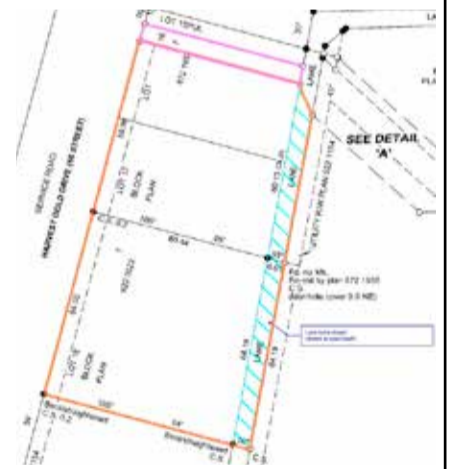

Proposed updates include the following:

- Adding definitions for terminology included in the Land Use Bylaw.
- Adding information to clarify the bylaw, such as noting that development must align with approved land use plans, adding that development decisions will be posted to the County website, and clarifying hazardous lands regulations.
- Changing site grading from a permitted use to a discretionary use on an interim basis while administration reviews site grading policy and regulations. This change means adjacent landowners are notified of proposed developments and have an opportunity to provide feedback.
- Requiring event venue operators to be onsite during events.
- Making amendments that improve efficiency, including allowing a dimensional tolerance of constructed buildings, allowing minor revisions to issued permits, and providing greater variance authority to avoid automatic refusal of applications.
- Providing clarity about when a proposed development is referred to Canadian Forces Base Edmonton for input.

A bylaw is needed to amend the existing Land Use Bylaw, and a public hearing must be held.

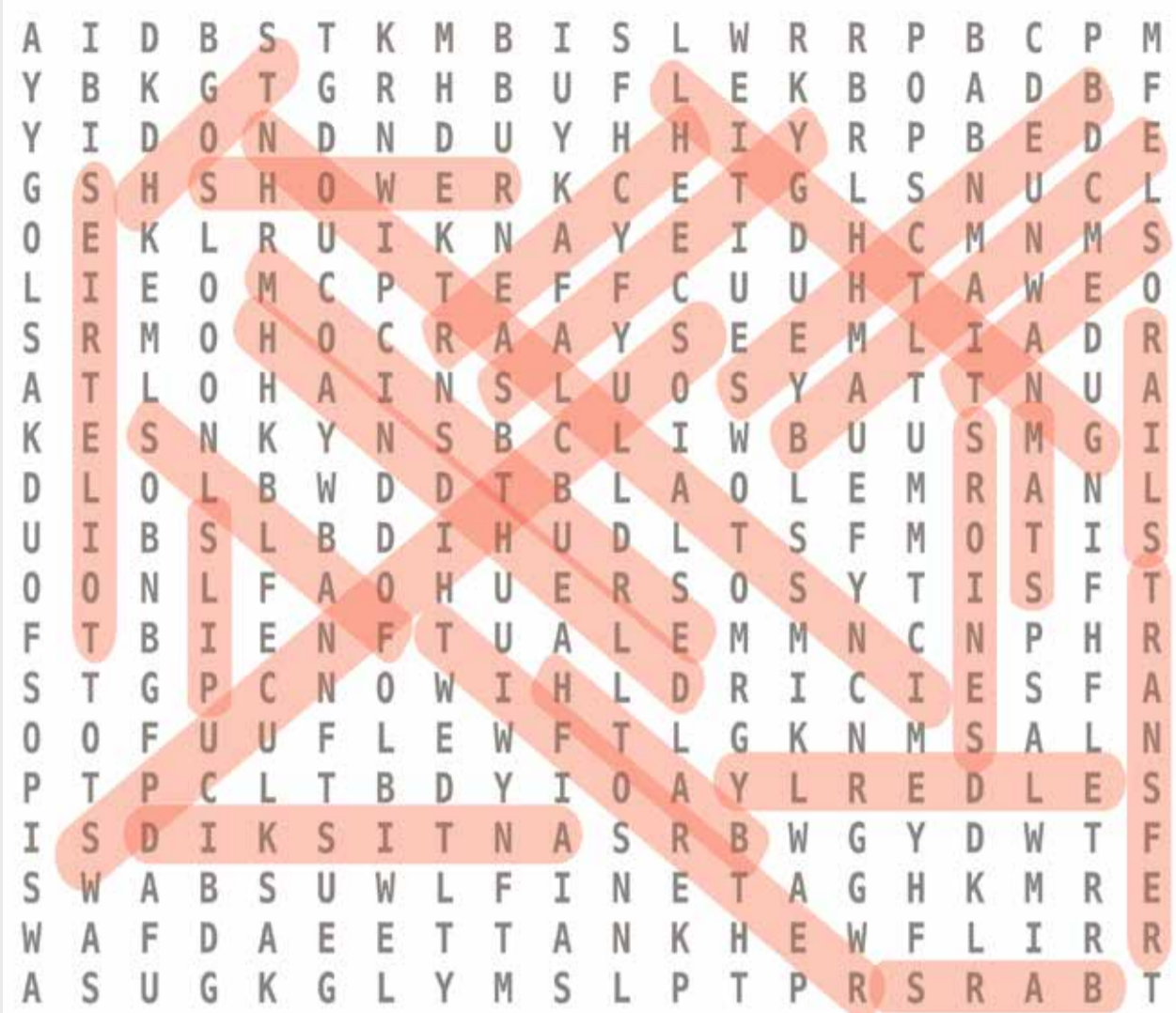
