



The Thorhild & District Agricultural Society is at again with their innovative ideas to promote growth and community development within the County of Thorhild. Following the platform, and mentorship, of the

Kitscoty Ag Society's "Klunker Dunker" fundraiser, Thorhild Ag Society got to work, diving into the endless legality and structural details and is now pleased to announce their very own "Splash & Crash" fundraiser, which will go towards the Thorhild & District

Ag Society Building Enhancement Fund. This will be a twopart fundraiser, engaging participants in the splash portion right now, and the crash portion to come later.

The morning of February 16 dawned bright marking the beginning of this entertaining event. Brent Chomay, with help from his son Levi, had worked together to prepare the car to reduce ecological damage after the event. All motor oil and transition fluid, along with any other contaminating fluids have been removed to ensure a fun, clean "splash" preserving the environmental impact of the dugout water. The 1977 Cadillac was donated for the event by Curtis Kuban and received its eye-catching logo paint job from Chiara Boychuk. Chomay, with the assistance of Robert Boychuk and his tractor, spent the morning setting up the car and a noteworthy fundraising sign.

The Splash & Crash Cadillac is located west of Thorhild along Highway 18, unable to be missed. Anyone willing to make a guess of thin ice is invited to visit the website and make their selection, guessing the time and date that the car will take its icy plunge. Selections are made per date at 10-minute intervals. The winner will receive 50% of the proceeds from the event. Following the break through the ice (Splash), the Cadillac will be removed from the dugout and the process will continue into its "Crash" stages. The Splash & Crash car will be transformed into a derby car and raffled off just in time for the chance to participate in Thorhild's Canada Day Demolition Derby.

their Kindness Crew on the evening of February 15 with the remnants of Valentine's Day still echoing its emotion of warmth and tenderness. Fabric generously donated by Tanya Halun (Gnome Matter What), was cut in heart shapes, ready for the evening project. The crew embarked on a journey of learning how to create no-sew heart-shaped stuffies that would be passed on at the evening's end.

Scissors snipped along the outside edges, creating the basis for the knots to be tied, holding the heart together. Laughter filled the library as bits of fluff flew around the table and clung to clothes and hands, wafting, and littering the floor with an artificial snowfall of crafting consequences. The design was suggested by Thorhild Librarian, Kathy Passay when she

came across the project on Pinterest. The project was definitely a learning experience but it brought about perseverance and leadership between the younger and older crew members. Struggling hands looked to more dextrous ones to complete the tricky knots and grins radiated with pride as the occasional heart decided its shape should now become a bean. Goal accomplished, not only the completion of the projects, but the purpose of coming together, sharing in happiness, and making others feel

good. The projects did not end there. Once cleanup was complete and a dinner shared, the Kindness Crew discussed the far-reachimpact ing these hearts could have. The programming was designed to give of oneself and a means of passing on kindness. The idea is to promote comfort, to pass on graciousness

and selflessness, to let a stranger know that someone out there cares, to offer a little drop of hope on an otherwise bleak day. "Squishy is comforting" commented one of the Crew, and a parent volunteer offered her novel poetry, "Here's a little heart to cuddle when your heart begins to crumble."

The Kindness Crew packed up their squishy hearts and headed to chat with the Thorhild Fire Department. The emergency service volunteers were interrupted in their training for a particularly good reason. Over a dozen hearts were gifted to the team to use in emergency service situations. Each heart crafted with laughter and compassion to be passed on when someone is in desperate need of a ray of sunshine, a cuddly, comforting piece of someone else's heart, even if it might be disguised in the shape of a bean.
