## Flags at half-mast honour the Battle of Vimy Ridge

The Town of Redwater, in addition to communities across the country, lowered their flags to half-mast on April 9 in a solemn remembrance of the anniversary of the battle of Vimy Ridge. The Town of Redwater stated, "In recognition of the sacrifices made at Vimy Ridge, we observe the National Day of Remembrance.

As a symbol of our gratitude and respect, our flags will be lowered to half-mast commemorating the bravery and sacrifice of those who fought in this historic battle.

On April 9, 1917, at 5:30am, the Canadian Corps embarked on what would become the Battle of Vimy Ridge, a historical and defining moment of Canadian victory.

Amidst unforgiving weather conditions and a barrage of the continuous assault of gunfire, the soldiers of the Canadian Corps displayed their valour by gallantly fighting their way up the ridge to take the high ground, which overlooked the Douai plain.

The victory was truly remarkable given the numerous failed attempts to retake the ridge since it had been taken by German soldiers during the first advances in 1914. Since its capture, approximately 150,000 French and British soldiers had lost their lives in attempts to recapture it. After months of careful planning and preparations, the Battle at Vimy Ridge proved to be successful.

During World War I, the Germans had spent several years fortifying their position on the ridge, which involved building deep bunkers, setting up overlapping

fields of machine gun fire and laying down layers of barbed wire. When the Canadians launched their attack, they were met with approximately 8,000 entrenched German defenders who were fully prepared to fight back. These defenders were equipped with heavy artillery and machine guns, making it difficult for the Canadians to advance. Despite these challenges, the Canadians pressed on with their attack, ultimately succeeding in breaking through the German defenses after several days of intense fighting.

The Battle of Vimy Ridge was a pivotal event that was fought by a group of nearly 15,000 soldiers who advanced towards the ridge under the cover of a creeping barrage consisting of almost one thousand heavy guns. The soldiers' objectives were to capture the ridge and gain control of an important observation point overlooking the Douai plain - a key

industrial and railway region in Northern France.

With great courage and determination, the soldiers managed to capture most of their objectives on schedule. By the afternoon, they had successfully secured the ridge, marking a significant milestone in the battle. However, the battle was not without its challenges. The soldiers faced fierce resistance from the enemy, and many lost their lives in the line of duty. Despite the adversities, the soldiers fought with unwavering commitment and bravery, which is a testament to their skill and dedication. The Battle of Vimy Ridge was a significant turning point in the First World War and continues to be remembered and commemorated as a significant event in Canadian and world history.

During this battle, all four divisions of the Canadian Corps fought together for

the first time. This was a significant moment that demonstrated the strength of Canadians when

they fought as a united force. It was also noteworthy that the Canadian Corps, a relatively small

colonial unit, accomplished what neither of its former colonial powers could achieve in retaking the ridge.

# The productivity imperative

## The productivity imperative

Talk of Canada's sluggish productivity performance has been trending. Senior Deputy Governor Carolyn Rogers recently said the need to bolster productivity is "an emergency - it's time to break the glass".

Productivity is the ability to convert resources (raw materials, people and capital) into output. It

ultimately determines a jurisdiction's living standards. Nobel Prize-winning economist Paul Krugman once remarked: "Productivity isn't everything, but, in the long-run, it is almost everything".

While that sounds important, it also sounds a bit theoretical. It's easy to dismiss productivity as an abstract academic concept.

Incomes are more relatable. In a Hub article released last week, University of

Calgary professor Trevor Tombe shows a clear connection between declining real earnings growth and weak productivity, warning the "Great Canadian Slump" is back.

Another way to make the productivity-wage connection is by looking at industries. Statistics Canada maintains detailed productivity accounts for individual industries. As shown in the below figure, there is a strong relationship between the

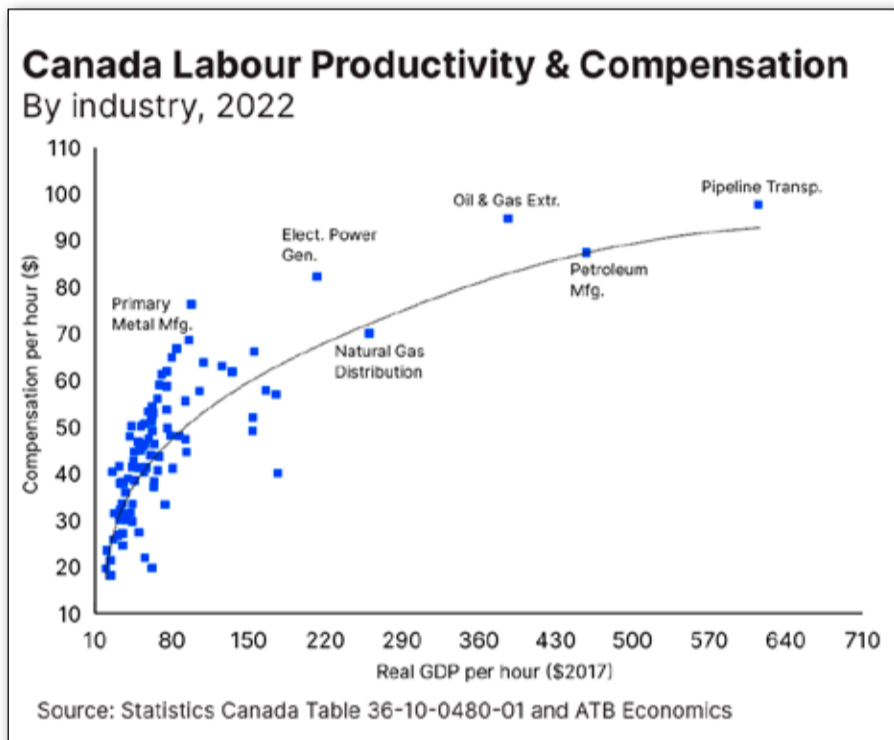
productivity of workers in an industry and the wages it pays.

Energy-related industries have among the highest levels of productivity and wages in Canada. We recently showed that the

majority of Alberta's higher overall labour productivity (vs. the national average) is due to the province having a higher concentration of workers in these industries.

Bottom line:

Productivity shouldn't be dismissed as a theoretical or academic concern. When labour productivity suffers on a sustained basis, it ultimately translates into lower overall wages for workers.

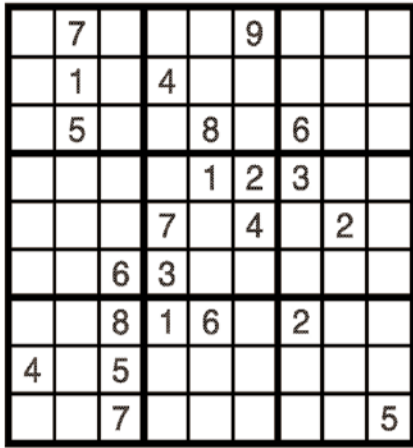

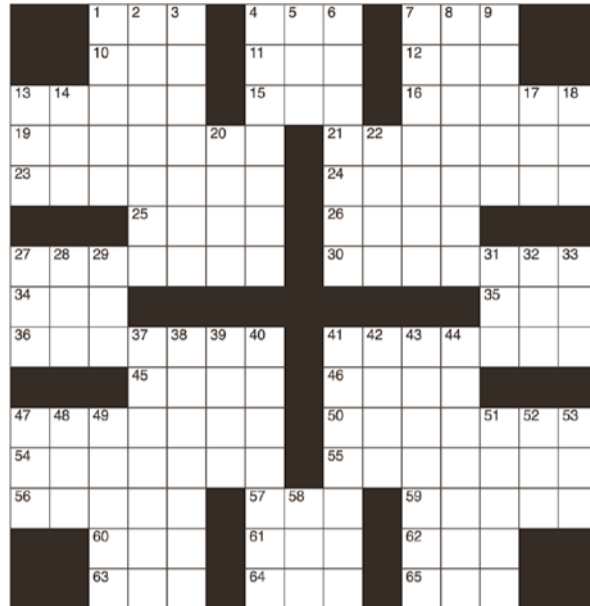



## COUNCIL MEETING HIGHLIGHTS April 9, 2024

Below is a brief summary of decisions at the April 9, 2024, Regular Council meeting:

### Delegation: MLA Glenn van Dijken

On behalf of the Government of Alberta, MLA Glenn van Dijken provided an update and answered questions from Council. After the presentation, Council thanked him for his attendance and accepted the update for information.

### Notice of Motions

Councillor Dafoe previously put forward two Notice of Motions: To revisit the Lagoon Dumping Fee Policy and Policy 1213 - Use of Emergency Services Facilities and Equipment. A motion to amend Bylaw 01-2023, Water and Wastewater Rates to reduce the dumping charge per user to \$200 was defeated. Council accepted the Notice of Motion regarding Policy 1213 - Use of Emergency Services Facilities and Equipment as information.

### Grants for Long Lake Water and Sewer

Council moved that Council advise the Government of Alberta and Long Lake Cottage Association that it will not be proceeding with the water line and sewage upgrade projects at Long Lake.

### Scenarios for the Maintenance of the Long Lake Community Block Wells Special Levy Bylaw

Council directed Administration to prepare a draft Special Levy for the Maintenance of the Long Lake Community Block Wells Bylaw based on Scenario 3.

### Scenarios for the 2024 Mill Rates Bylaw

Council directed Administration to prepare a draft 2024 Mill Rates Bylaw based on Scenario 1, municipal mill rates at status quo.

### Swimming Pool Rates - Amendments to Policy 606, Community and Recreational Services Schedule of Fees

Council directed Administration to bring back Policy 606, Community and Recreational Services Schedule of Fees as amended by increasing Swimming Pool rates consistent with Option B increases as recommended.

### Transfer from Reserves for a New Water Distribution Meter for Thorhild

Council directed Administration to return with additional information on the water distribution meter project costing.

### Community Planning Association of Alberta 2024 Conference

Council approved for Councillors to attend the Community Planning Association of Alberta 2024 Conference, April 29-May1, 2024, and that Administration bring back amendments to Policy 216, List of Pre-Authorized Meetings, Courses or Events for Council by adding "CPAA Conference" to the list.

Council accepted the report on the Community Economic Development Advisory Board Recommendation to Council for information.

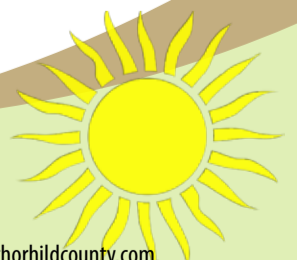

## Titans of Generosity

The Thorhild U15 hockey team, known as the Titans, took part once more in the annual Iceberg tournament held in Grande Prairie. The tournament served as a fundraiser for youth mental health. The team clinched second place and received a monetary prize, which they graciously donated back to the cause. Additionally, Ethan, Tristan, and Nathan were honoured with the Best Dressed award for their impeccable style and team spirit throughout the event.

## Did the legalization of cannabis lead to more car accidents?

(NC) It has been more than five years since the Government of Canada legalized cannabis. What impact has it had on our streets?

Driving after using cannabis is illegal. Public Safety Canada reminds us that drugs increase the chance of a crash. This is because cannabis use makes it harder to concentrate, reduces your attention span, causes your reaction time to slow down and alters your perception of time and distance.

But has legalization resulted in more crashes overall?

As risk assessment professionals, actuaries dove into this question.

A report from the Canadian Institute of Actuaries and the Casualty Actuarial Society looked at car accident reports and insurance claim data. They compared how frequent, how bad and how costly accidents have been after cannabis decriminalization or legalization in Canada and the United States.

Their data modelling and analysis found no statistically significant changes in the average cost and frequency of insurance claims or in the number of fatalities. In other words, the act of decriminalizing or legalizing cannabis has not been shown to result in more accidents.

Other factors were found to be far more likely to predict an increase in accidents than the legal status of cannabis. These include cycles in human behaviour and changes in weather – things like Monday morning or Friday afternoon commutes, the first snowfall of winter and changing the clocks for Daylight Saving Time.

Cannabis use certainly affects how people drive, but the research is showing that legalization itself has not led to an increase in accidents or fatalities.

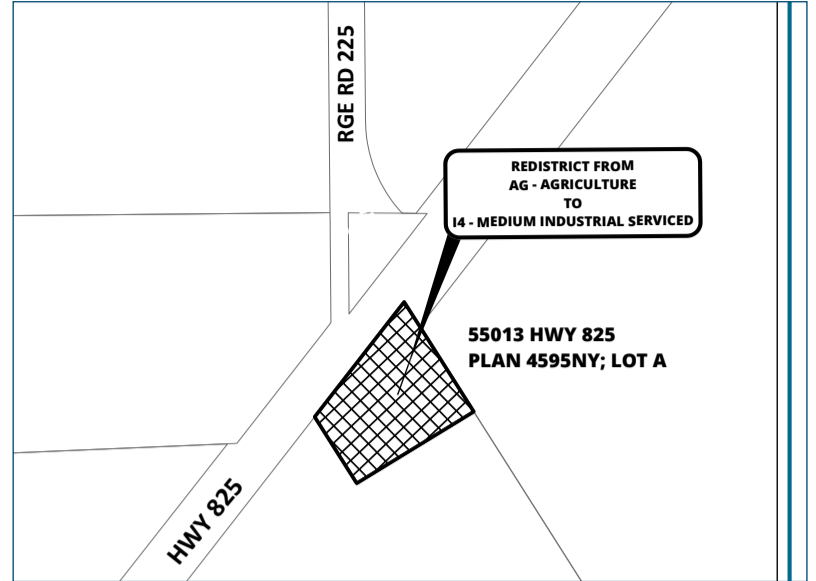

# Aspen Public Schools Board highlights

From the regular meeting held Thursday, April 4, 2024 at Whispering Hills Primary School

## Projected enrolments

Aspen View Public Schools anticipates a decline in student enrolment for the 2024-25 school year. Secretary-Treasurer Amber Oko presented enrolment projections that forecast a total division-wide enrolment of 2,596, down 29 students from the enrolment of 2,625 students on September 30, 2023.

Superintendent Constantine Kasrinos commented that declining enrolment is indicative of a trend where the student cohort starting in a new school is significantly smaller than the cohort that is leaving.

Headed that school principals have been asked to implement strategies to promote enrolment, including advertising, open houses and school branding, which he said is increasingly important in light of greater competition in education.



## Transportation fees

The Board of Trustees unanimously approved changes to transportation fees for the 2024-25 school year as recommended by the Transportation Committee.

The fee for Non-Eligible Riders — Kindergarten to Grade 6 students whose residence is less than 1 km from their designated school, and Grade 7-12 students whose residence is less than 2 km from their designated school — will be \$200

annually, to a family maximum of \$500 annually. The current fee is \$150 annually per student, with no family maximum.

The fee for Alternate transportation — students requesting seat on a different bus route than their designated home bus route — will also be \$200 annually, to a family maximum of \$500. The current fee is \$150 annually per student, to a family maximum of \$375.

## Summer School

Katherine Mann,

Associate Superintendent of Curriculum & Technology, advised the Board of Trustees that Aspen View Public Schools will once again be offering Summer School courses, including:

- Physical Education 10 (in person) at Edwin Parr Composite School.
- Career and Life Management (CALM) 20 and Financial Management 1010 (virtually).
- French Challenge 10/20/30 (virtually).
- Rock Camp at

Thorhild Central School.

## Nutrition grant

In February, the Government of Alberta announced an additional \$5 million in funding towards the school nutrition program for the 2023-24 school year. Secretary-Treasurer Oko advised the Board of Trustees that Aspen View Public Schools received an additional allocation of \$69,273 which will be distributed to schools based on their K-6

enrolment.

## Other highlights

The Board of Trustees unanimously approved the Board Self-Evaluation Process for 2023-24, as well as the process for an external evaluation of the Superintendent.

The Board of Trustees unanimously passed second and final reading of amended Policy 3 — Role of the Trustee, Policy 4 — Trustee Code of Conduct, and Policy 15 — School and Program Viability.
