As Alberta's economy continues to grow and diversify rapidly, some industries and job creators are experiencing a labour shortage in high-demand fields. The Alberta government is exploring various channels to train students entering skilled trades to address this issue and create opportunities for rewarding careers.

Under a new pilot program, the Alberta government will provide \$350,000 in funding to support the International Union of Operating Engineers (IUOE) Local 955 Trust Fund. This significant investment will enable the trust to deliver training for the Crane and Hoisting Equipment

Operator - Mobile Crane Operator apprenticeship program. The pilot program, set to take place at the Budd Coult's Apprenticeship and Education Centre training facility, offers a promising path for Albertans pursuing apprenticeship education in the Crane and Hoisting Equipment Operator field.

The IUOE (International Union of Operating Engineers) facility has been providing a wide range of training courses to thousands of workers in diverse sectors, including construction, transportation, and manufacturing. The courses are designed to equip trainees with

Every ride is an excellent get-together for people who have known each other for years, but also for newcomers, as this club is very open to newcomers, new ideas and innovation. It showed at this ride that there were new riders, young riders, senior riders, and everything in between. It was a mix of people with one significant thing in common: the love of horses while out on the trails. On Saturday morning, the first group went out for a 50-mile ride across the country, to be followed by the 25-mile riders at 9:00 and the intro (10 or 15 miles) at 10:00. The weather was cooperating, though a little less wind would have been nice, but who controls the weather? By the end of the afternoon, all riders came back safe and sound and gathered for a potluck supper and awards ceremony. They did it all over again on Sunday. The overall evaluation of the ride was that it is

an excellent first ride of the year because of the reasonably flat land – an easy start for horses and riders. “The biggest challenge was the date,” ride organizer and manager Irene van der Kloet says. “We needed this ride in a week-end after the cold and snow was gone, so the land is dry enough. But then it should take place early enough, so farmers are not seeding because it’s mostly on cropland”. That worked out well. “When I first contacted landowners, everyone was very willing to give permission, that was great. Then I found veterinarians, as we can’t do this ride without them, and I am lucky to have found two great veterinarians. When I mentioned to local people that I was organizing this ride, they willingly stepped up to volunteer, so it came together quite quickly. The biggest part was clearing a stretch of 2 kilometres of bush trail with a lot of deadfalls. I have been fortunate to get lots of help with

the entire organization, including the trail clearing. This is a great club to work with, open-minded and open to everyone, all to organize great rides”. The ride supported local businesses: water and porta potties were supplied by Metro from Waskatenau, and Anderson’s supermarket in Smoky Lake supplied food. ERA sponsors the ride, along with donations from Smoky Lake County, the Town of Smoky Lake, the Smoky Lake Lions Club, and a cash donation by a local couple. Local landowners were quick to permit the ride to take place on their land, with the Hutterite Colony of Smoky Lake as the most prominent landowner, along with other local landowners Nancy Senetza, Ernie Dombrosky, Mary Carson, Clive Palichuk, Kurt Melnyk, Daniel Jarema. ERA gives a big “THANK YOU” to all. Most of them have already given their permission for next year’s ride.

The Thorhild Bullarama, a thrilling bull-riding event, was recently organized successfully by the Thorhild & District Agricultural Society after a hiatus of 12 years. The Thorhild Community Association had hosted this annual event in the past, but due to the lack of volunteers, it had to be canceled. However, this time, the organizers enlisted the help of other organizations to make the event a resounding success. The Thorhild Minor Hockey hosted a delicious steak supper at the community hall before the event, while the Radway Lion Club hosted the concession at the arena. The Thorhild Fun Hockey was responsible for the clean-up on Sunday.

It was a sold-out show! To kick off the Bullarama, the Waste Management of Canada Kid's Meet & Greet event allowed twenty lucky kids to meet and greet the bullfighters and riders and collect their autographs. As bull riding fans poured in, the stands began to fill, and the crowd of spectators waited with high anticipation for the excitement to begin.

The competition was nothing short of intense, with eighteen fearless riders participating in the Bullarama. Cody Coverchuk, a name that will be remembered, emerged as the ultimate champion with an impressive

83-point ride in the long-go and another 83-point ride in the short-go, elevating him to the #2 spot in the season standings with the Bull Riders of Canada. Four riders managed to qualify for re-rides in the long-go, and a total of twenty-one bulls were taken on during the event, each ride a testament to the riders' courage and skill.

Thorhild Bullarama also feature a variety of fundraisers and the announcement of the recent Splash & Crash fundraiser winner. The evening's 50/50 winner, from Athabasca, took home \$1,680 which left the same amount going back to the maintenance fund for the Agriplex building. A quad donated by Conlon Motorsports was also raffled off and was won by local Megan Hay.

The Splash & Crash fundraiser, part one, was a car parked on a dugout, and people guessed what day & time it would fall through the ice. Kendra Toronchuk won half the \$8,310 pot for her winning guess of April 13 at 214pm. Part two, "Crash," is now underway, where raffle tickets are available to purchase for \$10 for a chance to win the car and drive it in the demo derby on July 1, or a \$1,000 cash prize equivalent.

With the enthusiastic participation of multiple organizations and volunteers, the Thorhild Bullarama was a tremendous success. The event was an excellent opportunity for the community to come together, enjoy thrilling bull-riding competitions, and show their support for local organizations.

the knowledge and skills required to excel in their respective fields.

The facility has also been actively involved in assisting workers to find employment with client employers through its placement services. This has helped many workers secure meaningful and sustainable employment while also contributing to the growth of the economy.

The pilot program will offer four sessions for the 2024-2025 academic year, offering a total of 40 training spaces for crane and hoisting equipment

operators in the province. In addition to the Budd Coult's Apprenticeship and Education Center training, NAIT, SAIT, and IUOE will offer more than 300 Mobile Crane 1 training seats in the upcoming academic year. This will enable more workers to receive quality training in a safe and conducive environment, using state-of-the-art equipment and facilities. The additional training spaces will also help to address the growing demand for skilled crane and hoisting equipment operators while also promoting safety and efficiency in the workplace.

Rajan Sawhney, Minister of Advanced Education, stated, "Apprenticeship education is an affordable and rewarding post-secondary option for learners. As demand for skilled tradespeople continues to grow, I am committed to ensuring that we have the workers we need to reach our potential and build our province's economic future. That is why Alberta is collaborating with a private sector union to provide hands-on training in apprenticeship education. This is a historic moment for skilled trades training in Alberta."

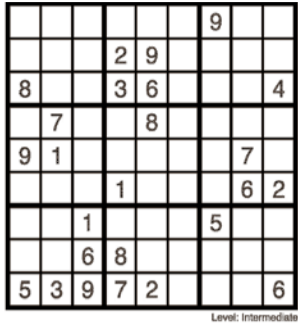

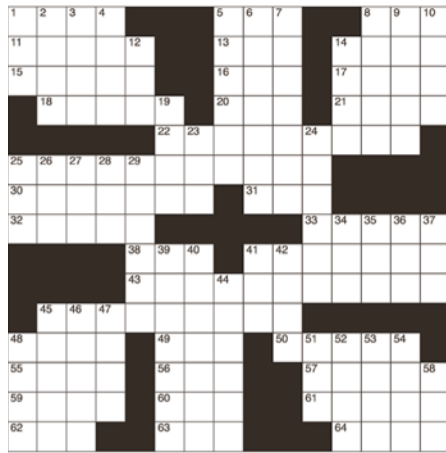

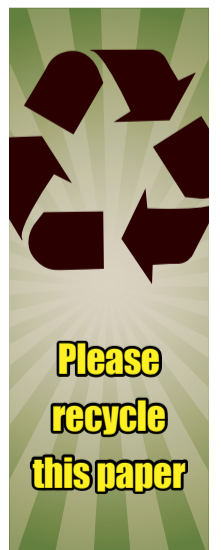

beginning with a look at a map of soil conditions across Alberta that highlighted the rich farming soil around the Redwater area.

From that point Warren engaged the group in an understanding of the varying microclimates throughout areas as small as a back yard, what constitutes healthy soil and an understanding that building healthy soil encourages and increases microbes, bacteria, and fungus. These microbes in turn enhance soil health by breaking down organic materials that can then be used as nutrients for plant usage and health.

The biological and chemistry lessons only

brushed the surface of a need for deeper understanding on metallic elements being transformed into ions and cation exchange capacities. Warren shared her knowledge of soil health diversity, fertilization to increase soil health and dispelling the myth that fertilizer feeds plants, as well as leading participants through the balancing act of organic matter/compost in soil.

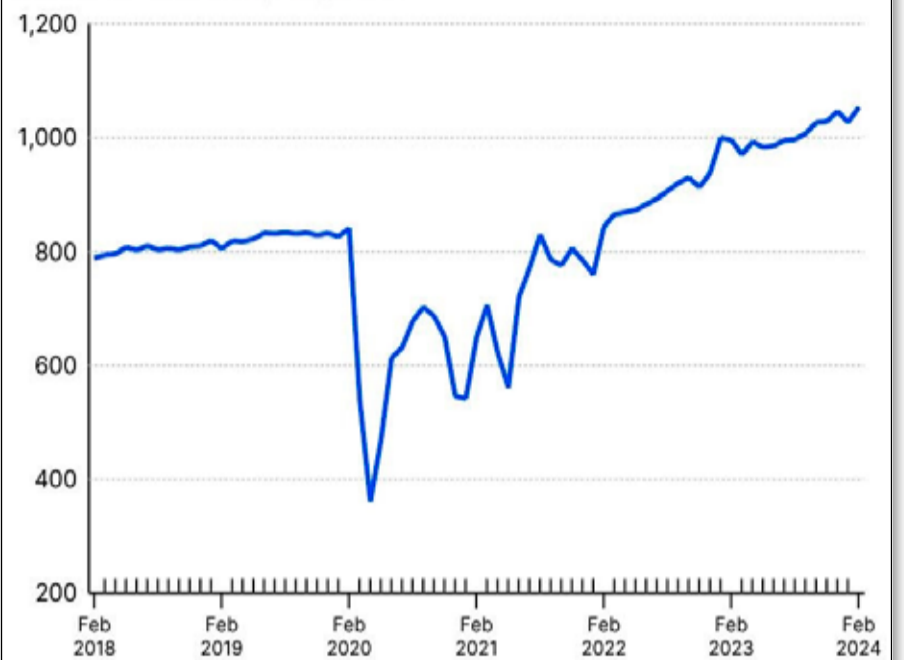
The Dirt-on-Dirt Workshop led by Caroline Warren was highly informative. It provided a reminder of basic understandings of drainage, buffer capacity, and growing zones. The session was also punctuated with humorous but effective tips such as the "tighty-white test." Attendees also gained

knowledge about fun facts such as soil pH. It was revealed that the pH of soil is heavily dependent on the rock that formed it. For instance, shale and sandstone, which are acidic, would break down and form acidic soil. Caroline Warren shared her vast knowledge gained from gardening across Canada and her own exploration into an understanding of soil. Participants left with an overwhelming amount of knowledge surrounding cover crops, soil sampling, earthworm counts, soil texture, and much more.

Restaurant and bar sales on the rise

Sales* at Alberta restaurants and bars bounced back in February, growing by 2.6% to \$1.05 billion—the eighth increase in nine months.

Compared to February 2023, sales were 5.8% higher.

Ongoing population growth is a contributing factor here as are higher prices, but it is still a positive sign for the sector (and the overall economy) that sales have not been on a downward slide given the impact of high interest rates on discretionary income.

With regard to prices, the cost of food purchased from restaurants in Alberta did not change in February

compared to January while the cost of alcoholic beverages served in licensed establishments fell, so sales rose even after adjusting for inflation.

Prices have, however, gone up since last year. Between February 2023 and February 2024, the cost of food purchased at restaurants rose by 4.7% while alcoholic beverages came in 3.1% higher. As such, growth in year-over-year sales was due to both increased volume and increased prices.

It is important to note here that these numbers are averaged across all restaurants and bars with individual sales performance and prices varying from establishment to establishment. Higher sales, moreover, do not

necessarily speak to profitability, since operating costs (including food inputs) have also increased.

In terms of what's next, we are expecting consumer spending to be constrained by the impact of higher borrowing costs on household budgets and this could cut into restaurant and bar spending this year. On the other hand, population growth and tourism finally getting back to normal after the pandemic will support increased spending as will the fact that consumers may hold off on big ticket/interest sensitive purchases but still find room in their budgets to enjoy getting food and drinks from restaurants and bars.

FIRE BAN IN EFFECT



FIRE BAN

Effective April 25, 2024 at 1:00 p.m.

Due to severe fire hazard conditions of ground and surface fuels, Thorhild County has upgraded the existing Fire Restriction to a Fire Ban.

Current fire hazards conditions are considered extreme.

Prohibited Activities:

Outdoor fires including: open fires, brush piles, smudge fires, solid fuel fire pits, campfires, burn barrels, incinerators, explosive targets, and the discharge of fireworks.

Operating an Off-Highway Vehicle on Public Lands which is not part of emergency response operations.

Allowed Activities:

Fires which are contained in CSA approved cooking appliances which are fueled by liquid fuel (propane, natural gas, or camping fuel) such as Barbecues or Camping Stoves.

Note:

Thorhild County urges everyone to recognize and proactively eliminate any possible outdoor sources of heat and ignition. Users of indoor solid fuel fireplaces are asked to ensure embers are not escaping from chimneys.

Having a fire extinguisher and/or water source readily available while performing outdoor activities is strongly advised.

As per Thorhild County Emergency Services Bylaw 12-2023, fines for engaging in a prohibited activity during a Fire Ban is \$3000.
