



Highlights of Town of Redwater MDP open house

The Municipal Development Plan (MDP) review process was discussed at the open house on July 3rd. The event included information sessions with the MDP Steering Committee, Administration, and Greenspace Alliance and interactive displays to collect feedback. Common questions and their answers were also addressed during the event.

The Municipal Development Plans (MDPs) need to be redone to meet the standards set by the Municipal Government Act. The provincial government reviewed the MDP as part of the Municipal Accountability Program and found it didn't need to comply with the standards. The government directed the update to meet current requirements. Additionally, the current MDP has not been updated since 2009, so this update will ensure it meets provincial standards and reflects the community's and residents' current needs and desires.

The Municipal Development Plan (MDP) outlines the broad vision, goals, and policies for long-term community development. Consequently, the Land Use Bylaw (LUB) provides specific regulations and standards for land use and development on individual parcels of land. Moreover, the MDP

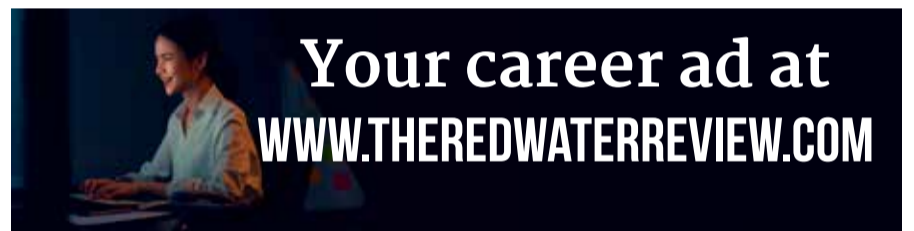
The CN Station activities are a wonderful way to spend time

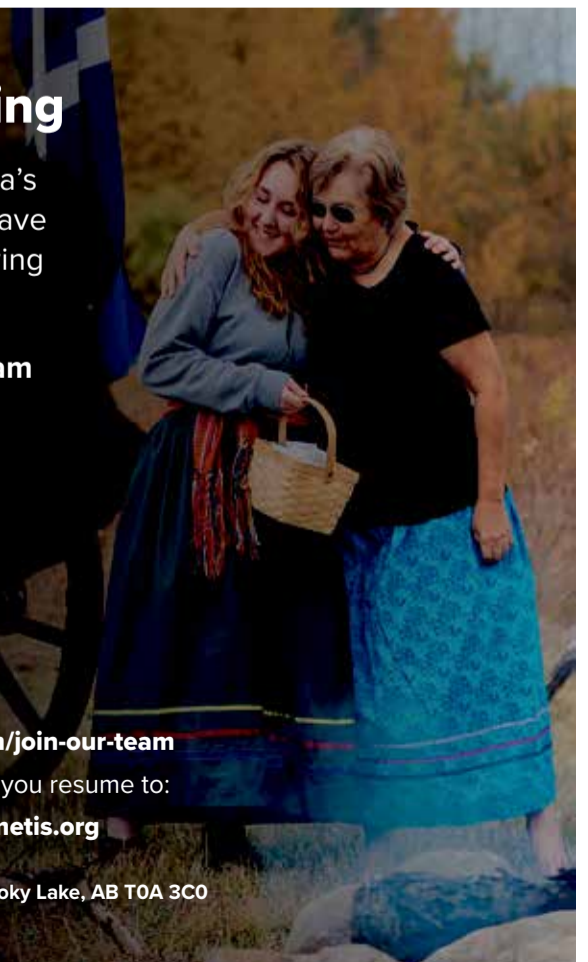

focuses on high-level goals such as increasing green spaces and recreational areas to enhance residents' quality of life, and the LUB implements the MDP's vision on a practical, regulatory level by specifying requirements for new developments in specific zones, such

as including a certain percentage of green space or parkland. The Town of Redwater did not receive provincial or federal funding for the Municipal Development Plan (MDP) update. The project is being funded internally through the town's budget to ensure complete control over the process and

outcomes and to reflect the unique priorities and vision of Redwater's residents and stakeholders. In many smaller municipalities, there is a lack of resources to handle large projects independently. This underscores the important role of consultants in providing technical support and planning input, which includes

organizing public engagement events and drafting policies. It's important to note that while consultants help shape proposals, the town's administration is responsible for ensuring that the final product meets the community's needs and complies with legal requirements. Lastly, the administration has a duty

to engage with the community, gather feedback, and ensure that the Municipal Development Plan (MDP) aligns with the municipality's goals and legislative standards. Furthermore, the Town of Redwater is not considering implementing a 15-minute city model due to its rural setting and

residents' reliance on cars to access services and amenities. The town's priority is improving and maintaining the infrastructure and services that meet the specific needs of its rural setting.
