
Each time an Outline Plan is considered, a non-statutory public hearing may be held.

# **Provincial government offers** courses to local ESS teams

In a recent reconnect meeting held in Thorhild County, a dedicated group of volunteers convened to reinforce their commitongoing ment to establishing a strong Emergency Social Service (ESS) team. This group is vital for improving community resilience, and the efforts of all participants are sincerely appreciated.

During this reconnect meeting, volunteers were introduced to a range of free online courses offered by the provincial government deepen their to understanding of Social Emergency Services and the diverse roles within the field. These courses present an excellent opportunity for individuals to refine their skills and expand their knowledge, ultimately improving their effectiveness in emergency situations.

Among the available courses is "Behaviour and Disasters," which addresses the complexities of predicting human reactions during emergencies or disasters—an often challenging task for ESS practitioners and volunteers. This session will explore common scenarios and the various behaviors individuals may exhibit in the face of disaster.

Additionally, it will provide practical suggestions and strategies designed to mitigate the effects of emergencies on both individuals and communities, focusing on preparedness and response at all stages: before, during, and after an event.

Other offerings include an ";Introduction to Emergency Social Services," which lays the foundation for understanding the ESS framework; "Registrations and Reception Centre Program and My Alberta Emergency Registration System," which instructs on managing registrations and the operational aspects of reception centers; "Donations Management," focusing on effectively handling community donations during crises; "ESS Coordinator," which provides insights into the leadership and coordination roles within ESS; and "ESS Basics," detailing

the essential principles and practices that underpin the work of Emergency Social Services. For more information on these courses or to express

Who is Quick Dick McDick (QDM)? Education is, at its core, about shaping a positive future. It provides stability, relationships, compassion, knowledge, and social skills to those who will lead our communities in the coming decades. When done well, these future leaders will strive for equity in environmental stewardship, economic growth, political leadership, and corporate responsibility. However, achieving this ideal is increasingly difficult. Our education system, originally designed on a factory model, has undergone improvements—one of the most critical being the shift from an impersonal process to a relationship-based approach. Research shows that one caring adult can make the difference between a child developing emotional resilience struggling with or

However, society, technology, and changing family dynamics have placed even more pressure schools. on Many

youth today feel isolated, and for some, school is the only place where they have a caring adult in their corner. At the same time, financial strain, rising inflation, and a lack of education funding stretch resources thinner than ever. ranks last in Canada for per-student education funding. 

- Edmonton CUPE has had five unsuccessful bargaining meetings, with workers claiming nearly a decade without a meaningful wage

settled without strikes. but they are the exceptions, not the norm. In Sturgeon School Division, CUPEworkers-including EAs, administrative staff, and librarians—have not received an inflation-matching wage increase in eight years. In that time, division trustees gave themselves a substantial raise. These support workers, who already earn the lowest CUPE wages in Alberta, are now left outside in the cold, fighting for fairness.

Meanwhile, some students who rely on these caring


